LUBBOCK LEGAL PROFESSIONALS ASSOCIATION SCHOLARSHIP RULES 2018 Scholarship Award of \$500.00

- 1. Applicant must have a minimum "B" average.
- 2. Applicant must show a need for the scholarship.
- 3. Applicant must be well-rounded in school activities.
- 4. Applicant must be eligible to enroll in the September fall term.
- 5. Applicant must submit the following:
 - a. Letter stating why Applicant would like to pursue a career in the legal field;
 - b. Letter from school counselor, principal or program director;
 - c. Letter from two (2) persons not related to Applicant and with whom Applicant is well acquainted;
 - d. List of school activities;
 - e. Transcript; and
 - f. 3" x 5" photograph of Applicant—school photograph acceptable.
- 6. This scholarship shall be available to high school seniors, as well as those enrolled in school of advanced education, such as junior colleges, community colleges, four-year colleges, universities or business colleges. Any candidate who has applied for the award in any one contest, including the winner, shall be eligible to apply again in the usual manner for a future award.
- 7. Deadline for all entries is **JANUARY 5**, 2018. That is, the application and all other requirements must be postmarked on or before January 5, 2018.
- 8. Decision of the judges shall be final.
- 9. One-half (¹/₂) of the funds awarded will be paid before the beginning of the fall semester upon presentation of an official school invoice. The remaining funds will be paid before the beginning of the spring semester upon presentation of an official school invoice.
